Malawi College of Health Sciences is inviting applications from suitably qualified male and female candidates to pursue a face-to-face Bachelor's Degree programme in Clinical Medicine in the 2024/2025 Academic Year

ADMISSION REQUIREMENTS:

i. Entry at Year One

Applicants must have a Malawi School Certificate of Education (MSCE) or its equivalent with six **credit passes**. The credit passes must be in English, Mathematics, Biology, Physics, Chemistry and any other subject obtained from 2020 to the current year. Candidates should also have a minimum of 4 points in each of the following subjects: Biology, Physics and Chemistry.

ii. Entry at Year Three

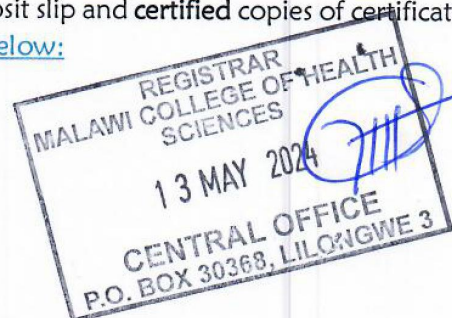
Applicants must have a Diploma in Clinical Medicine obtained from a recognised institution with a minimum of two years of work experience after internship. Candidates should also have a Malawi School Certificate of Education (MSCE) or its equivalent with six credits. Four of the credit passes must be in English, Biology, Mathematics and Physical Science. Candidates that do not have Physical Science must instead have either General Science or Physics and Chemistry. Applicants must also be registered with Medical Council of Malawi and possess a current practising license.

Mature entry candidates will be expected to complete a block of bridging modules prior to entering year three of the program. The bridging block will be offered in a semester before the start of year three of the programme.

Interested candidates should apply by downloading an application form from our website www.mchs.mw. The application should include an application letter, a detailed Curriculum Vitae with valid email addresses, scanned copies of the bank deposit slip and **certified** copies of certificates to registrarupgrading@mchs.mw or through the address below:

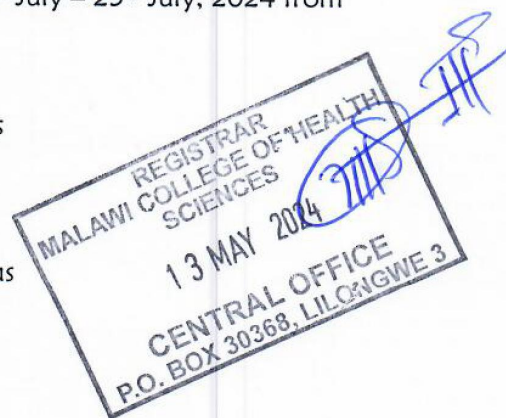
